

**TOWN OF PINETOP-LAKESIDE**

**ORDINANCE NO. 13-378**

**AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, REVISING THE TOWN CODE BY MOVING TOWN CODE CHAPTERS 2.12 "TOWN MAGISTRATE," AND 2.28, "MAGISTRATE COURT ADMINISTRATIVE FEES," TO NEW CHAPTER 2.14 "TOWN MAGISTRATE AND COURT ADMINISTRATIVE FEES"; AND ADOPTING NEW CHAPTERS 2.12 "TOWN CLERK," NEW CHAPTER 2.18 "TOWN MARSHAL/CHIEF OF POLICE," AND NEW CHAPTER 2.22 "TOWN ENGINEER."**

**WHEREAS**, the proposed Town Code Chapter 2.12 "Town Clerk," Town Code Chapter 2.14 "Town Magistrate and Court Administrative Fees," Town Code Chapter 2.18 "Town Marshal/Chief of Police," and Town Code Chapter 2.22 "Town Engineer." was declared to be a public record by adopting Resolution No. 13-1291; and

**WHEREAS**, pursuant to Arizona Revised Statutes § 9-802, a "Public Record" with three (3) copies placed on file with the Town Clerk may be adopted by reference; and

**WHEREAS**, three (3) copies of the "Public Record" created by Resolution No. 13-1291 are on file with the Town Clerk; and

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona as follows:


**Section 1.** Town Code Chapter 2.12 "Town Magistrate," is moved to new Chapter 2.14 and further amended; and Town Code Chapter 2.28 "Magistrate Court Administrative Fees," is moved to new Chapter 2.14 "Town Magistrate and Court Administrative Fees". All action taken in accordance with former Chapter 2.12 and Chapter 2.28 prior to moving and amendment remains fully in effect.

**Section 2.** Town Code Chapter 2.12 "Town Clerk," Town Code Chapter 2.14 "Town Magistrate and Court Administrative Fees," Town Code Chapter 2.18 "Town Marshal/Chief of Police," and Town Code Chapter 2.22 "Town Engineer." were declared to be a public record by adopting Resolution No. 13-\_\_\_\_.


**Section 3.** If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of Town Code Chapter 2.12 "Town Clerk," Town Code Chapter 2.14 "Town Magistrate and Court Administrative Fees," Town Code Chapter 2.18 "Town Marshal/Chief of Police," and Town Code Chapter 2.22 "Town Engineer" adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
