**RESOLUTION NO. 18-1440**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA AUTHORIZING THE SUBMISSION OF AN APPLICATION(S) FOR FY 2018 STATE COMMUNITY DEVELOPMENT BLOCK GRANT (“CDBG”) FUNDS, CERTIFYING THAT SAID APPLICATION(S) MEET THE COMMUNITY'S PREVIOUSLY IDENTIFIED HOUSING AND COMMUNITY DEVELOPMENT NEEDS AND THE REQUIREMENTS OF THE STATE CDBG PROGRAM, AND AUTHORIZING ALL ACTIONS NECESSARY TO IMPLEMENT AND COMPLETE THE ACTIVITIES OUTLINED IN SAID APPLICATION.**

**WHEREAS,** the Town of Pinetop-Lakeside is desirous of undertaking community development activities; and

**WHEREAS,** the State of Arizona is administering the Community Development Block Grant (“CDBG”) Program; and

**WHEREAS,** the State CDBG Program requires that CDBG funds requested address one of the three Congressional mandated National Objectives; and

**WHEREAS,** the activities within the CDBG Regional Account Application address the community's identified housing and community development needs, including the needs of low and moderate income persons; and

**WHEREAS,** an Applicant of State CDBG funds is required to comply with the program guidelines and Federal Statutes and regulations:


**NOW, THEREFORE, BE IT RESOLVED,** that the Mayor and Council of the Town of Pinetop-Lakeside authorizes application(s) to be made to the State of Arizona, Department of Housing for FY 2018 CDBG funds, and authorize the Mayor to sign the application(s) and contract(s) or grant documents for receipt and use of these funds for the Johnson Drive Infrastructure Improvements Project; and

**THAT,** this application for State CDBG funds meets the requirements of low-moderate income benefit for activities justified as benefiting low- and moderate income persons, aid in the prevention or elimination of slum or address blight or addresses an urgent need which poses a threat to health; and


