RESOLUTION NO. 14-1301

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, APPROVING THE PROPOSED CONTRACT AND AUTHORIZING THE PINETOP-LAKESIDE POLICE DEPARTMENT TO PURCHASE A DUI ALCOHOL ENFORCEMENT POLICE PACKAGE MOTORCYCLE AT A PURCHASE PRICE NOT TO EXCEED \$27,000.00 UTILIZING GOVERNOR'S OFFICE OF HIGHWAY SAFETY (GOHS) FUNDING.

WHEREAS, the Pinetop-Lakeside Police Department has relied upon the Governor's Office of Highway Safety funding to support participation in DUI enforcement and;

WHEREAS, the Pinetop-Lakeside Police Department seeks to continue with its proud participation; however, fiscal constraints continue to challenge the Pinetop-Lakeside Police Department's ability to fund vehicles necessary to address the current DUI issue fully and;

WHEREAS, the Pinetop-Lakeside Police Department continues to work cooperatively with regional partners in the White Mountain DUI task Force as a means to address the current DUI issue and;

WHEREAS, due to limited manpower, recruitment and retention problems coupled with increasing calls for service, proactive enforcement for on duty officers has proven inadequate and difficult. Under these conditions, Pinetop-Lakeside Police Department officers cannot have a significant impact on the DUI problem and;

WHEREAS, with funding assistance from GOHS (since 2004), Pinetop-Lakeside Police Department led the way in forming the White Mountain DUI Task Force to address DUI issues and local DUI arrests have radically dropped off and;

WHEREAS, during peak seasons, holidays and special events the Town of Pinetop-Lakeside Police Department sees a spike in DUI offenses and arrests due to the number of visitors our Town receives, there are many outside the reach of our public information campaigns which continue to drive drunk when they visit our Town and;


WHEREAS, grant funding would fund a fully Marked DUI Alcohol Enforcement Police Package Motorcycle to support and enhance DUI Alcohol Enforcement throughout the Town of Pinetop-Lakeside.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona, hereby approves the proposed contract and authorize the purchase of a fully Marked DUI Alcohol Enforcement Police Package Motorcycle to support and enhance DUI Alcohol Enforcement throughout the Town of Pinetop-Lakeside at a purchase price not to exceed \$27,000.00 utilizing GOHS grant funding. The Town Manager or Mayor are authorized to

execute any and all documents reasonably necessary or needed for this program including any grant applications and related documents.


