

## TOWN OF PINETOP-LAKESIDE

### ORDINANCE 16-401

#### AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AMENDING “TOWN CODE CHAPTER 17.116 – PLANNING AND ZONING COMMISSION ORGANIZATION AND PROCEDURE” AND ADOPTING BY REFERENCE AMENDED SECTION 17.116.010 (A).

- Section 1. Adoption by Reference. Pursuant to A.R.S. §9-802 the Town hereby adopts a text amendment to the Town Code, amending Chapter 17.116 – Planning and Zoning Commission Organization and Procedure and Adopting by reference Amended Town Code Chapter 17.116, Amendment to Section 17.116.010 (A).
- Section 2. Effective Date: This Ordinance is to be effective when publication and posting pursuant to A.R.S. §§ 9-812 is accomplished.
- Section 3. Copies of this text amendment. At least three (3) copies of Town Code Chapter 17.116 – Planning and Zoning Commission Organization and Procedure dated December 15, 2016 and any future amendment or revisions, shall be kept on file in the office of the Town Clerk and on the Town website for public access. Additional copies may be purchased by the public. Copies placed for public access shall be readily available for public inspection during normal working hours.
- Section 4. Section 17.116.010 (A) is hereby amended to reflect as follows:
- 17.116.010 Establishment – Composition – Terms of members – Vacancies – Compensation of members.\*
- A. There is established a Planning and Zoning Commission of the Town to consist of seven (7) members, ~~five (5)~~ **four (4)** of whom shall be residents of the incorporated boundaries of the Town and ~~up to two (2)~~ **three (3)** of whom may reside within the unincorporated areas of the Town as defined by the boundaries of the Blue Ridge School District No. 32, but not residing in another incorporated municipality, each of whom shall be appointed by the Town Council. The members of the Commission shall serve three (3) years except as hereinafter provided. The members of the first Commission appointed hereunder shall serve for the following terms: two (2) members shall be appointed for a term of one (1) year; two (2) members shall be appointed for a term of two (2) years; three (3) members shall be appointed for a term of three (3) years. In the event of a death, resignation, or removal from the Commission, the vacancy shall be filled by the Council for the unexpired term. Members of the Commission may, after public hearing, be removed by the Council for inefficiency,

of duty, or malfeasance in office. The Council shall file a written statement of the reasons for removal.

Section 5. Severability. All ordinances, or parts of ordinances, adopted by the Town of Pinetop-Lakeside in conflict with the provisions of this ordinance or any part of the Town Code adopted herein by reference, are hereby repealed, effective as of the day this ordinance is effective.

PASSED AND ADOPTED by a majority vote of the Town Council in an open meeting by the Town Council, Town of Pinetop-Lakeside, Arizona, on the 15<sup>th</sup> day of December 2016, to be effective upon the expiration of a thirty (30) day period following adoption and publication and posting, pursuant to A.R.S. §§9-812 and 9-813, is completed.
